

## 5K Run Waiver, Release and Authorization 2024

### Liability and Consent

*I have read and accepted the release of liability and consent*

IN CONSIDERATION of the acceptance of my application and the permission to participate as an entrant, or participant in the SIBOS 2024 5K run and walk **on Wednesday 23 October 2024** (the Event) and any other SIBOS 2024 5K run and walk activities that take place prior to or after the event.

I am medically able and properly trained. I agree to abide by any decision of an Event official relative to my ability to safely complete the Event. I recognize that participation in the Event is a potentially hazardous activity and I willingly assume all risks associated with such participation, including, but not limited to, falls; contact with other participants, spectators or others, or vehicular or other traffic; the effects of the weather, including heat and/or humidity, wind, cold temperature, and wet or icy surfaces; falling tree branches or other overhead objects; traffic; and the crowded nature and other conditions of the course, all such risks being known and appreciated by me.

I, for myself, my heirs, executors, administrators, successors and assigns, HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE the parties involved in this event, including but not limited to Beijing Xin-Yue United Automobile Co., LTD, Olympic Park Police Station, Chaoyang Branch, Beijing Municipal Public Security Bureau, Cultural and Tourism Department, Beijing Olympic Forest Park Development and Management Co., Ltd., Beijing Huaxing Zhongtai Sports Technology Co., Ltd, MCI China, and all other associations, sanctioning bodies and sponsoring companies, and all their respective agents, officials, servants, contractors, representatives, elected and appointed officials, successors and assigns OF AND FROM ALL claims, demands, damages, costs, expenses, actions and causes of action.

Whether in law or equity in respect of death, injury, loss or damage to my person or property HOWEVER CAUSED, arising or to arise by reason of my participation in the said event, whether as a spectator, participant, competitor, volunteer or otherwise, whether prior to, during or subsequent to the event, AND NOTWITHSTANDING that same may have been contributed to, or occasioned by, the negligence of any of the aforesaid. I FURTHER HEREBY UNDERTAKE to HOLD AND SAVE HARMLESS and AGREE TO INDEMNIFY all of the aforesaid from and against any and all liability incurred by all of them as a result of, or in any way connected with, my participation in the said event.

The event may be cancelled at the discretion of Swift due to inclement weather and including but not limited to: strong winds, hurricane, tornado, earthquake, flooding, air quality, extreme heat or cold, or other "act of God", Pandemic, Epidemic, Global health concerns, concerns for the health and safety of our participants and volunteers, traffic related accident on the course, fire, or a terrorist act.

I have completely read this document and fully understand its contents. My signature attests to this on behalf of myself and my executors, personal representatives, administrators, heirs, next-of-kin successors, and assigns.

## Privacy and Personal Data

### 1. WHO ARE WE?

The company responsible for processing your personal data is:

### 2. HOW DO WE COLLECT PERSONAL DATA ABOUT YOU?

We get your personal data from the following sources:

- From you directly
- From a person who registers you on your behalf (colleague, assistant, etc.)

Swift provides the ticketing and registration platform that collects the data from the participant registration form and stores the participant information on its servers located in the EU. Limited participants' information will be shared with our data processor **MCI Group (Shanghai) Pte Ltd** (including participants' identifier and T-shirt sizes information), to ensure all necessary participants' material is ready for the run.

The results of the event (finishing time) will be collected by the event coordinator, added to the participant information, submitted to Swift and made available to the participants of the 5K run and walk on Sibos.com website. Swift will publish and store the 5K run and walk results, ranks of individuals, and keep this data for the purpose of staging the Event(s) and for statistical analysis and reporting. This also allows participants to rank themselves against other participants.

### 3. WHY DO WE PROCESS YOUR PERSONAL DATA?

We process personal data about you for the following purpose:

- Organize your participation to Sibos 5K run and walk
- Statistical analysis and reporting on the Event

- Swift and **MCI Group (Shanghai) Pte Ltd.** to use your name, voice, video, audio, photographs, motion pictures, pictures, records and/or photographic portraits as is or with changes/alterations in any broadcast, telecast, publication, advertising, promotion in relation to Sibos 5K run and walk without any compensation.

You are not required to provide us with your personal data. However, if you do not provide your personal data, you will not be able to participate at the Sibos 5K run and walk.

#### 4. WHAT PERSONAL DATA DO WE PROCESS ABOUT YOU?

For the purpose described above in Section 3, we may process the following types of personal data:

- Contact information (name, country, email address)
- Size of t-shirts
- Results of the run (including finishing time and rank)
- Your photographs, motion pictures, video, audio, photographic portraits, records
- Your hotel (for the purposes of providing transportation)

#### 5. WHY ARE WE ALLOWED BY LAW TO PROCESS YOUR PERSONAL DATA?

Our processing of your personal data requires a legal basis. By law, we are allowed to process your personal data described above in Section 4 based on the following legal basis:

- The processing of your personal data is necessary for the performance of this 5K run and walk Waiver, Release and Authorization 2024 and your participation to the Event.
- Swift and the participants to the Sibos 5K run and walk have a legitimate interest in the processing of your personal data, so as to allow Sibos participants to participate in a well-organized, secure and fun activity, and enable Swift to communicate about Sibos initiatives.

#### 6. HOW DO WE SHARE YOUR PERSONAL DATA?

We may share your personal data with:

- Suppliers or vendors that assist our company (e.g., consultants, IT service providers, law firms)
- Chinese officials (e.g. police officers for security purposes)
- Other Swift entities.
- We may use your photographs, motion pictures, voice, video, audio, photographic portraits, records in relation to Sibos 5K run and walk website, and subsequent Sibos publications

As a reminder, in compliance with the Sibos Registration Policy, Swift reserves the right to photograph and videotape all Sibos events and participants and to use such photographs and videos in any internal and external communication referring to Sibos or to Swift services and products, such as on its websites and intranet, in the Sibos Insider, Sibos Programme, Sibos tools, Wrap-up reports and in its annual reports as well as on social media channels including but not limited to Weibo, WeChat, Douyin, Little Redbook, LinkedIn, X, SmugMug, Flickr, SoundCloud, Instagram or YouTube.

#### 7. WHEN DO WE TRANSFER YOUR PERSONAL DATA ABROAD?

For the purposes described above in Section 3, most of your personal data will be stored and accessed by Swift authorized personnel in the European Union. A limited set of your personal data will be shared or collected and stored in China, where the 5k run and walk will take place, as described in Sections 2 and 6.

#### 8. HOW LONG WILL WE KEEP YOUR PERSONAL DATA?

Swift will keep your personal data for the following period of time:

- 3 years

#### 9. WHAT ARE YOUR RIGHTS?

In general, you have the following rights:

- You can get an overview of what personal data we have about you
- You can get a copy of your personal data in a structured, commonly used and machine-readable format
- You can get an update or correction to your personal data
- You can have your personal data deleted or destroyed
- You can have us stop or limit processing of your personal data
- If you have given consent for us to process your personal data, you can withdraw your consent at any time. Your withdrawal will not affect the lawfulness of the processing carried out before you withdrew your consent

Under applicable law, there may be limits on these rights depending on the specific circumstances of the processing activity. For accountability reasons, please also note that Swift keeps track of requests received from individuals and related actions taken.

## 10. CONTACT

If you have any question or any complaint regarding the processing of your personal data, you can contact **MCI Group (Shanghai) Pte Ltd** or the Swift Privacy Officer or submit a complaint with the supervisory data protection authority in your country of residence, place of work, or where an incident took place.

This agreement is governed by the applicable law of Belgium. If any provision is determined to be unenforceable, all other provisions shall be given full force and effect.
