

# Sibos Registration Policy

Registration for and participation in Sibos are subject to this Sibos Registration Policy ("Registration Policy"). By submitting your registration for Sibos, you will be considered to have agreed to this Registration Policy.

#### **Definitions**

'Swift' means S.W.I.F.T.SC and any off its subsidiaries and branches worldwide. 'Sibos' means the 2024 Sibos event organised by or for Swift from 21-24 October 2024 at China National Convention Center No.7 Tianchen East Road, Chaoyang District, Beijing China.

'Sibos Registration Office' means BCD Meetings & Events, the company registered in the UK to which Swift has sub-contracted the registration to Sibos.

## Registration

Sibos is exclusively open to representatives of Swift Users (that is, Swift shareholders, Sub-members, and other eligible Swift users), representatives from Sibos Partners, and other persons invited or approved by Swift. The individuals participating at Sibos are hereinafter referred to as "participant(s)," "you," or "delegate(s)."

#### **Procedure**

All registrations must be made in advance online via the official Sibos registration website only. Swift acknowledges receipt of registrations. Registrations are processed on a first-come, first-serve basis. Once capacity is reached, any further registrations are put on a waiting list. Swift reviews registrations with a view to ensuring appropriate representation from the targeted audience. Swift will promptly notify those persons whose registrations could not be accepted. In any event, confirmation of registration is conditional upon full payment.

## Sibos Tools login - the digital experience

After the availability of the Sibos digital experience, user profile is automatically created following fully completed registration (including payment if applicable). The login to the Sibos digital experience is based on a verification code sent to the email address used to register. You are entirely responsible for maintaining the confidentiality of your account, as well as for all activities that occur under your account. In addition, you agree to notify Swift immediately of any (suspected) unauthorized use of your account or any other breach of security. Swift will not be liable for any loss that you may incur in the event of unauthorized access or use of your account.

Subjected to the Registration Policy, you will receive restricted access to the Sibos Tools.

These Sibos Tools will be made available to all Sibos participants who are duly registered and include:

- The Sibos participant directory
- The Sibos chat service
- Sibos.com including the restricted pages for participants
- The Sibos Mobile Application (Sibos App)

The Sibos Tools are made available to you for networking, preparation and planning of the conference, and follow-up purposes. Sibos Tools also allow you to contact and exchange information with other Sibos participants and Sibos exhibitors. By using the Sibos Tools, you hereby agree to abide by Terms of Use of Sibos.com & Sibos Mobile Application. In particular, you agree (i) not to use these Sibos Tools or any other related products and services for any other purposes and (ii) to comply at all times with any applicable terms of use as notified to you by Swift.

## **Registration Fees**

Sibos registration fees are as set out on the official Sibos registration website (http://www.sibos.com/).

The registration fee for a participant includes participation in the conference, access to the exhibition, access to all or part of the Sibos Tools and lunch.

Registration fees and any other related fees and charges are net of any taxes, such as, but not limited to, VAT (when applicable).

## **Indirect Taxes / Withholding Taxes**

For the correct application of indirect tax rules, similar but not limited to VAT, GST, withholding taxes or Sales tax, you are deemed to be located at the place of the "Company details" as reported on the Sibos Registration form. Upon specific request, the invoices can be sent to the place indicated under "Invoice details". The billed entity remains however the "Company details" entity.

As an Overseas company, S.W.I.F.T.SC is not required to charge Chinese VAT on any services related to participation at Sibos. It is up to Chinese established customers to verify whether to self-assess and clear the withholding VAT obligation with the most applicable withholding VAT rate, this process cannot be controlled by S.W.I.F.T.SC.

All fees for services not rendered in China such as, but not limited to virtual attendance and advertising, Sibos App, Sibos TV, Sibos.com, flyers, media sponsors are deemed to be provided at the place of the "Company details" and will be subject to the rules defined by the European VAT Directive EC/2006/112.

Companies residing in Malaysia, South Africa, Zimbabwe, Ghana, Kenya, Nigeria, Thailand may be charged the local tax at domestic rates according to the country's regulation on digital services.

Fees and charges are net of any local taxes applicable in the country of the participant, such as, but not limited to (when applicable) VAT, GST, Sales tax,

withholding tax or any similar tax of any nature whatsoever. All present and future participant's local taxes, as well as fines and/or penalties and/or interest assessed directly or indirectly on such amounts (if any) which may apply to fees or charges due for or in connection with the conference, will always (even retroactively) be borne by you. You are solely responsible for paying any such local taxes in addition to applicable Swift fees, charges, and computed taxes, if any. Swift cannot be held responsible for seeking any refund of such local taxes and will not initiate any procedure to that effect.

### **Payment Method**

Swift accepts payment for Sibos registration by credit card or electronic transfer. If you prefer to pay by electronic transfer, please indicate your intention to do so by using the appropriate section on the official Sibos registration website. An invoice with relevant payment instruction details will be sent to you via a link in your confirmation email.

## **Cancellation of Registration**

Full refund (less a EUR 250 cancellation charge) of the registration fee paid to Swift will be made on written notification of cancellation received by the Sibos Registration Office before 23 September 2024.

As an exception, Swift will accept your cancellation and will refund the registration fee in full (as sole and exclusive right and remedy) in the event you test positive for COVID-19 and you can no longer attend as long as you send an email to registration@sibos.com:

- i) explaining the aforementioned circumstances
- ii) and attaching a doctor's certificate, certifying that you have tested positive.

Participants are fully responsible for getting the appropriate visas in time.

The cancellation of your registration for non-obtaining Visa or legal authorities documents for entering in China remains your responsibility. No refund will be granted in case you don't obtain your visa on time.

The deadline for submitting refund requests based on the aforementioned exceptional cases is 11 November 2024. After this date, no refund will be granted.

In the exception of a cancellation approved after 23 September 2024, a refund will be processed minus Euro 250,- (as an administrative fee) and minus Euro 275,- for the Digital Pass. A link to register for a Digital pass will be sent to you.

In the event of complimentary passes and discounted passes for Exhibiting companies, for the avoidance of doubt, the aforementioned passes will need to be used diligently by the Exhibitor. No refunds will be processed in case the Exhibitor purchases such passes in any other way.

The cancellation of hotel reservation is under the participant or company responsibility and should be managed directly with the partner BCD Meetings & Events. Hotel

cancellation charges will be charged to the participant, as stipulated in the hotel booking confirmation.

#### Substitution

You may transfer your registration to another person within your organisation at any time, with a written notification addressed to the Sibos Registration Office. The deadline for submission is five (5) working days before the opening of the event, i.e.,14 October 2024, Monday. After that date, we will not process any substitution. If a transfer of registration results in a refund and a new payment, administrative cancellation charge of EUR 250 will be charged to the participant who is cancelling.

The transfer of any associated hotel reservations requires credit card details of the substitute to be communicated to the official appointed housing agent (BCD Meetings & Events).

The transfer of hotel reservations is subjected to the reservation terms and conditions, including where applicable any hotel guarantee provisions.

## **Event Cancellation, Postponement or Alteration**

If, for any reason whatsoever, Swift is forced to cancel, postpone, or materially alter Sibos, in whole or in part, it will use all reasonable efforts to notify all registered participants reasonably in advance thereof. As sole and exclusive right and remedy, full refund of the registration fee paid to Swift will be made on reasonable demonstration to Swift that such cancellation, postponement, or alteration adversely affects the participant concerned.

Swift shall not be liable whatsoever to the Company or Participant for any cancellation, postponement of Sibos or non-performance of its obligations under this Registration Policy to the extent to which such delay, cancellation, postponement or non-performance arises from any Force Majeure Event. Force Majeure Event means any event or circumstance, or combination of events or circumstances, which are beyond the reasonable control of, and are not attributable to Swift and that affect materially the organisation of the event or render the organisation of the event impossible. Without prejudice to the generality of the foregoing, Force Majeure Event includes but is not limited to serious political unrest, war, terrorist attack or serious threat, weather and natural disaster, infectious diseases, negative travel advice or other similar circumstances.

## **Event Rules and Regulations**

Whilst participating in Sibos, you are required to comply with any policies or directions (such as but not limited to security, health, and safety regulations) in force at the time of the event, given by or for Swift or any other relevant third party, including the person responsible for the premises where Sibos takes place or any competent authority. You must wear your badge at all times. Your badge is strictly personal and may not be transferred to another person or modified. Swift accepts no responsibility for any belongings you may bring to Sibos. Bringing such belongings is at your own risk.

#### **Lead Retrieval Device**

Scanning of your badge by an Exhibiting company should always be done with your consent. By scanning your badge, the Exhibiting companies will collect your first name, family name, company name and e-mail address. This information should only be used by the Exhibiting companies for the purpose of evaluating attendance and to present their products and services.

### Wi-Fi

In addition to the Sibos Tools, Swift will offer all Sibos participants free access to Wi-Fi at the China National Convention Centre (CNCC). Swift will provide each participant with a unique and personal set of credentials to connect to the Sibos Wi-Fi network.

Credentials are unique and linked to a participant, therefore, they should not be shared with any other party, pre, during or post Sibos. To generate these credentials, Swift will collect specific personal identify information during the registration process to help enable access. Once this information is acquired, Swift will transfer this data to the legal and telecommunication authorities in China, who are sole responsible for credentials management and monitoring as they may deem appropriate.

Based on current planning, five (5) is the maximum number of devices that can be authorised using a single set of credentials, with all of these devices able to concurrently connect.

You are required to use the Sibos Wi-Fi legally, professionally and in accordance with the Wi-Fi Acceptable Use Policy, in a way that would not violate the right of any third-party or create any interference on the network.

In accordance with the <u>Wi-Fi Acceptable Use Policy</u>, the Wi-Fi provided at Sibos is monitored by Swift for security and quality control purposes. In this regard, only your IP address and traffic data are initially processed. Only if further investigation is needed, your personal details may be used in order to contact you to gather further information or to discuss our concerns or be able to respond to a threat. Illegal use or serious security breaches may be reported to the authorities or any competent law enforcement agency.

## **Photographs and Videos**

The Company may photograph or videotape its own promotional events and materials at its own stand space at its own discretion but subject to all applicable laws, in particular but not limited to any and all personal data protection regulations. All other photography and videotaping is strictly prohibited. The Company shall ensure that their staff members, agents, sub- contractors as well as any Participants are informed about and do not object to their image being used for these purposes.

Any photography or videotaping outside of your stand space must be performed by the Sibos Exhibitors Media Services or approved by Sibos Exhibitions Office if you wish to bring in your own suppliers. The Organiser, the official show photographer and accredited Press are exempted from this rule. Accredited members of the press are authorized to selectively capture and share portions of the conference sessions in accordance with fair use principles.

However, it is strictly prohibited for all participants to record and publicly distribute the entire sessions as this would compromise the integrity of the event's content and speakers.

In accordance with the Sibos Registration Policy, Swift reserves the right to photograph and videotape all Sibos events and participants and to use such photographs and videos in any internal and external communication referring to Sibos or to Swift services and products, such as on its websites and intranet, in the Sibos Issues, Sibos Programme, Sibos tools – Digital experience, Wrap-up reports and in its annual reports as well as on social media channels such as LinkedIn, X (Twitter), SmugMug, SoundCloud, Instagram or YouTube.

#### **Press**

All Sibos conference sessions are open to any and all registered Sibos delegates, including journalists and other media-related delegates (unless advised to the contrary). You acknowledge that Swift does not track journalist attendance at Sibos and is unable to advise which sessions journalists will attend. Furthermore, Swift is not able to intervene with the media on behalf of any Sibos speakers.

You agree that Swift has no responsibility for - nor control over - any coverage (including but not limited to photos, quotes, session reviews, session write-ups, social media posts) published in the media.

### **Speakers**

At Sibos, as a speaker, you agree to comply at all times with the Code of Conduct as provided hereunder and all applicable laws and regulations.

## **Sanctions and Other Legal Restrictions**

The event that you have registered for might be subject to export control, sanctions or other legal restrictions. Swift aims to comply with all laws and regulation applicable to it and therefore reserves the right to withhold acceptance of or cancel your registration based on restrictions arising from any such applicable regulations. By registering for this event, you acknowledge that it is our sole responsibility to be in compliance with any sanctions and export control regulation. that is applicable to you and Swift hereby disclaims all liability for your non-compliance with above mentioned laws and regulations.

## **Cancellation or Revocation of Registration of Participants**

Swift may at any time, without prior notice, cancel or withdraw your registration should it be determined by Swift in good faith that

- doing so is necessary to avoid violation of sanctions, export control or other laws
- ii) you are acting against the interests of Swift, including, but not limited to, by threatening or participating in litigation or claims adverse to Swift or
- iii) you have failed to comply with the Sibos Registration Policy or have otherwise breached any current or past obligations owing to Swift.

## **Indemnity**

You acknowledge and agree that you will indemnify Swift against any damages incurred by Swift as a result of a third-party claim arising from your Sibos registration or participation, except to the extent such damages were directly caused by Swift.

## Liability

Swift's potential liability in connection with Sibos (whether in contract, tort or otherwise) is limited to the total amount of your registration fee. Furthermore, any claim for indirect, special, or consequential loss or damage of any kind or for any loss of business or profit, revenue, anticipated savings, contracts, loss of or corruption to data,

loss of use, loss of goodwill, interruption of business or claims of other parties or other similar pecuniary loss howsoever arising, even if Swift has been advised of their possibility, is expressly excluded. To have a valid claim against Swift relating to your Sibos registration or participation, you must notify Swift within six months after the Sibos ending date. You agree to exonerate Swift from any liability relating to claims notified after that time limit.

## **Intellectual Property**

The Sibos tools contain proprietary materials of Swift SC and/or of its suppliers. All rights are reserved. Any and all rights, including title, ownership rights, copyright, trademark, patents, and any other intellectual property rights of whatever nature, in the services or products described on the Sibos Tools, including any associated processes or any derivative works, will remain the sole and exclusive property of Swift and/or its suppliers.

## Copyright

By participating in the Sibos event as a speaker, for all contributions provided for Sibos (including but not limited to oral presentation, print materials or handouts, PowerPoint slides, Al products and other digital media), you grant Swift an irrevocable, royalty-free, non-exclusive, sub-licensable, perpetual license to reproduce, use and distribute the contributions by any means (including but not limited to audio, video, photography, printed materials, digital media and Al). You retain ownership of your pre-existing copyrights contained in the contributions. You warrant that the contributions are either owned by you, in the public domain, or licensed with full authority from the owner and grant Swift the rights identified herein and that the contributions contain nothing defamatory or otherwise unlawful.

#### **Trademarks**

Swift is the trade name of S.W.I.F.T. SC. The following are registered trademarks of Swift: 3SKey, Innotribe, MyStandards, Sibos, Swift, SwiftNet, Swift Institute, the Standards Forum logo, the Swift logo, Swift GPI with logo, the Swift GPI logo, and UETR. Other product, service, or company names in this publication are trade names, trademarks, or registered trademarks of their respective owners.

#### **Code of Conduct**

Swift values and encourages freedom of expression. To maintain a right balance between such freedom of expression, and potential abuses of the Sibos Tools, you agree to:

- 1. Always respect Swift's name, reputation, goodwill, and other business assets when using the Sibos Tools.
- 2. In particular, respect the Swift Trademark Guidelines when referring to Swift or its products and services.
- 3. Ensure that any content that you make available does not infringe the rights of Swift, another user, or any third party.

- 4. In particular, refrain from infringing any intellectual property rights, privacy and data protection laws, confidentiality commitments, trade or business secrets, banking secrecy, or other laws when using the Sibos Tools.
- 5. Refrain from making any statements that would be insulting, threatening, libelous, obscene, offensive to religious, political, or ethical beliefs, discriminating or racially oriented, or otherwise infringing any applicable legislation or third-party rights.
- 6. Refrain from making any statements that would be disrespectful, misrepresenting, or otherwise harmful to Swift, another user, or any third party.
- 7. Refrain from discussing topics with competitors that could give rise to competition law issues (such as price-fixing or market allocation agreements), and always conduct discussions with competitors in accordance with applicable antitrust regulations.
- 8. Refrain from using the Sibos tools to participate in or send contests, pyramid systems, or chain letters.
